Whitefly	2.3 – 3.5 ozs. /A	Make applications when adult whiteflies first appear and before the development of nymphs. Apply prior to the establishment of heavy infestation. Do not apply more than 9.2 ounces (0.4 lbs. a.i.) per acre per calendar year of this product nor exceed 4 applications per calendar year. Apply in a minimum finished spray volume of 5 gals. per acre by aircraft and 15 gals. per acre by ground. The tendency for resistance development in whiteflies has been observed. To reduce the potential for resistance, rotate applications of this product with insecticides that have a different mode of action. Foliar absorption may be affected after cutout which could affect whitefly control. For best results after cutout, use a penetrating adjuvant (including oils) to increase contact or absorption.
