### **APPLICATION INFORMATION**

For best results, apply Clever<sup>™</sup> 50 DF at the first sign of mites before adult mite build up. Use higher rates on moderate-to-high mite infestations, large trees with dense foliage, or for extended residual control. Lower rates may be used in conjunction with other IPM strategies, or for shorter residual control later in the season. It is not, however, recommended to use less than the label's rates since it will result in poor performance and contribute to resistance development.
