APPLICATION INFORMATION

Inspirato 2 F must be ingested by insect larvae to be fully effective. Applications must be in a manner that assures uniform and thorough coverage. Higher water volume and increased spray pressure generally provide better coverage.

Apply the amount specified in the following tables with properly calibrated aerial or ground spray equipment. Prepare only the amount of spray solution required to treat the measured acreage. Use the lower labeled rates for light infestations of the target lepidopteran species and the higher labeled rates for moderate to heavy infestations. Inspirato 2 F may be applied in either dilute or concentrate sprays so long as the application equipment is calibrated and adjusted to deliver thorough, uniform coverage. Use the specified amount of Inspirato 2 F per acre regardless of the spray volume used.
