This powerful insect growth regulator (IGR) contains pyriproxyfen, an active ingredient proven to protect stone fruits, strawberries, apples, citrus and other crops. Reemit 35 WSB is gentle on bees and beneficial insects but is very effective in targeting and eliminating scale insects as well as other pests, including first generation pear psylla, rosy apple aphid, leafrollers, spotted tentiform leaf miner and first-generation codling moth.

Reemit 35 WSB works by suppressing the hatching of eggs laid by treated adults and by inhibiting the adult emergence of targeted insects. Available in a convenient four ounce, water-soluble packet, it should be applied by ground using airblast equipment. Full, thorough coverage is important for best results and should be limited to two applications per season to optimize resistance management.

APPLICATION INFORMATION

Reemit 35 WSB acts by suppressing embryogenesis within the insect egg and by inhibiting metamorphosis and adult emergence of target insects. Reemit 35 WSB has no activity on adult insects but hatching of eggs laid by treated adults will be suppressed. Since Reemit 35 WSB is an Insect Growth Regulator (IGR) and activity depends on the insect's development, evidence of activity will be slower than typical contact insecticides.

Reemit 35 WSB comes in an easy-to-use water-soluble packet and may be applied by ground using airblast equipment. Thorough coverage is critical for control. It is essential to use adequate water volume to ensure thorough coverage.

MANAGING RESISTANCE:

Repeated use of the same class of insecticides with similar modes of action can lead to the buildup of resistant insect strains. To optimize resistance management practices, make no more than two applications of Reemit 35 WSB per growing season. Reemit 35 WSB may be used in alternation with other IGR materials possessing dissimilar modes of action and/or with other chemical classes of insecticides. Follow local, state, and federal IPM and IRM recommendations. Read and follow all product labels before applying any insecticide.
