A single application of long-lasting Reemit 0.86 EC offers season-long pest control, crop protection, and invaluable peace of mind.

### APPLICATION INFORMATION

Reemit™ 0.86 EC is intended for use in Integrated Pest Management (IPM) or Insect Resistance Management (IRM) programs. Reemit 0.86 EC will not control insect adults, and it is recommended to be used in combination and/or rotation with other IPM or IRM materials. Contact your local state extension service for details.

Reemit 0.86 EC acts by suppressing embryogenesis within the insect egg and by inhibiting metamorphosis and adult emergence of target insects. Reemit 0.86 EC has no activity on adult insects but hatching of eggs laid by treated adults will be suppressed. Since Reemit 0.86 EC is an Insect Growth Regulator (IGR) and activity depends on the insect's development, evidence of activity will be slower than typical contact insecticides.

Reemit 0.86 EC may be applied with superior spray oils at ½ to 1%. Follow the manufacturer's directions and recommendations on timing and rates.  NOTE: For scale apply during emergence of scale crawlers, do not apply more than 16 fl ozs of Reemit 0.86 EC per acre per year.

Thorough coverage is essential for good control.  NOTE: Do not make more than 2 applications of Reemit 0.86 EC per acre per year.
