For suppression of Garden Symphylan (*Scutigerella immaculate*) apply Serpent 1 EC as a soil incorporated application prior to planting. Apply in a minimum of 10 gallons per acre using ground equipment.

The total amount of Serpent 1 EC allowed per acre per season and the pre-harvest intervals (PHI) are listed in the above table. The soil application of Serpent 1 EC must be considered when calculating the total amount of product used per acre per season (soil applications).

### **RESTRICTIONS:**

- Apply as required by scouting, usually at intervals of 5 or more days. Timing and frequency of applications should be based upon insect populations reaching locally determined economic thresholds.
- For succulent and dried shelled peas and beans, do not graze livestock in treated areas or harvest vines for forage or hay.
