PRODUCT INFORMATION

Prozare SC is a broad-spectrum systemic fungicide for the control of Ascomycete, Basidiomycete and Deuteromycete diseases in barley, corn (field corn, field corn grown for seed, popcorn, and sweet corn), peanut, and wheat. Under conditions conducive to extended infection periods or high disease pressure, another registered fungicide may be needed once this product's maximum application rates have been reached. Under these conditions use another fungicide registered for the crop/disease.

Resistance Management

For resistance management, **Prozare SC** contains two Group 3 fungicides. Any fungal population may contain individuals naturally resistant to **Prozare SC** and other Group 3 fungicides. A gradual or total loss of pest control may occur over time if these fungicides are used repeatedly in the same fields. Appropriate resistance-management strategies should be followed.

To delay fungicide resistance, take the following steps:

- Rotate the use of Prozare SC or other Group 3 fungicides within a growing season with different groups that control the same pathogens.
- Use tank mixtures with fungicides from a different group that are equally effective on the target pest when such use is permitted. Use at least the minimum application rate as labeled by the manufacturer.
- Adopt an integrated disease management program for fungicide use that includes scouting, uses historical information related to pesticide use, crop rotation, and which considers host plant resistance, impact of environmental conditions on disease development, disease thresholds, as well as cultural, biological and other chemical control practices.
- Monitor treated fungal populations for resistance development.
- Contact your local extension specialist or certified crop advisor for any additional pesticide resistance-management and/or IPM recommendations for specific crops and pathogens.

Spray Equipment/Volumes

Prozare SC may be applied by either ground, aerial and/or chemigation application equipment. Equipment must be properly calibrated before use.

For ground application, apply in a minimum of 10 gallons of spray solution per acre. For aerial application, apply in a minimum of 2 gallons of spray solution per acre unless stated differently in the **USE DIRECTIONS FOR SPECIFIC CROPS** section. Check equipment calibration frequently. Complete coverage and uniform application are essential for the most effective results, especially when lower spray volumes are applied. If necessary, increase the spray volume per acre for complete crop coverage.



Mixing Procedures

Prepare no more spray mixture than is necessary for the immediate operation. Thoroughly clean spray equipment before using this product. Maintain maximum agitation throughout the spray operation. Do not let the spray mixture stand overnight in the spray tank. Flush the spray equipment thoroughly following each use and apply the rinsate to the previously treated area or dispose of the rinsate according to local regulations.

Prozare SC Alone

Add ½ of the required amount of water to the mix tank. With the agitator running, add the **Prozare SC** to the tank. Continue agitation while adding the remainder of the water. Begin application of the solution after the product has completely and uniformly dispersed into the mix water. Maintain agitation until all of the mixture has been applied.

Prozare SC + Tank-Mix Partners:

Add ½ of the required amount of water to the mix tank. Start the agitator running before adding any of the tank-mix partners. In general, tank-mix partners should be added in this order: products packaged in water-soluble packaging*, wettable powders, wettable tank mix granules (dry flowables), liquid flowables, liquids, and emulsifiable concentrates. Always allow each tank-mix partner to become fully and uniformly dispersed before adding the next product. Provide sufficient agitation while adding the remainder of the water. Maintain agitation until all of the mixture has been applied.

*Note: When using Prozare SC in tank mixtures, all products in water-soluble packaging should be added to the tank before any other tank-mix partner, including Prozare SC. Allow the water-soluble packaging to completely disperse before adding any other tank-mix partner to the tank.

It is the pesticide user's responsibility to ensure that all products are registered for the intended use. Read and follow the applicable restrictions and limitations and directions for use on all product labels involved in tank mixing. Users must follow the most restrictive directions for use and precautionary statements of each product in the tank mixture. This product must not be mixed with any product that prohibits such mixing. Tank mixtures or other applications of products referenced on this label are permitted only in those states in which the referenced products are registered.

Prozare SC is compatible with most insecticide, fungicide, herbicide, and foliar nutrient products. However, the physical compatibility of **Prozare SC** with tank-mix partners should be tested before use. To determine the physical compatibility of **Prozare SC** with other products, use a jar test, as described below.

Using a quart jar, add the proportionate amounts of the products to 1qt. of water. Add wettable powders and water-dispersible granular products first, then liquids and emulsifiable concentrates last. After thoroughly mixing, let stand for at least 5 minutes. If the combination remains mixed or can be remixed readily, it is physically compatible. Once compatibility has been proven, use the same procedure for adding required ingredients to the spray tank. For further information, contact your local Atticus, LLC representative.

The crop safety of all potential tank mixes including additives and other pesticides on all crops has not been tested. Before applying any tank mixture not specified on this label, the safety to the target crop should be confirmed. To test for crop safety, apply **Prozare SC** to the target crop in a small area and in accordance with label instructions for the target crop.

Aerial Application: Avoid application under conditions when uniform coverage cannot be obtained or when excessive spray drift may occur. Aerial application is prohibited in New York State.

Chemigation Application: Apply Prozare SC through irrigation equipment only to crops for which chemigation is specified on this label.

Prozare SC alone or in combination with other pesticides, which are registered for application through irrigation systems, may be applied through irrigation systems. Apply this product only through center pivot, solid set, hand move, or moving wheel irrigation systems. Do not apply this product through any other type of irrigation system. Illegal pesticide residues in the crop can result from nonuniform distribution of treated water. If you have questions about calibration, you should contact State Extension Service specialists, equipment manufacturers, or other experts. Do not connect an irrigation system (including greenhouse systems) used for pesticide application to a public water system, unless the pesticide label-prescribed safety devices for public water systems are in place. A person knowledgeable of the chemigation system and responsible for its operation, or under the supervision of the responsible person, shall shut the system down and make necessary adjustments should the need arise.

Operating Instructions

- 1. The system must contain a functional check-valve, vacuum relief valve, and low-pressure drain appropriately located on the irrigation pipeline to prevent water-source contamination from backflow.
- 2. The pesticide injection pipeline must contain a functional, automatic, quick-closing check-valve to prevent the flow of fluid back toward the injection pump.
- 3. The pesticide injection pipeline must also contain a functional, normally closed, solenoid-operated valve located on the intake side of the injection pump and connected to the system interlock to prevent fluid from being withdrawn from the supply tank when the irrigation system is either automatically or manually shut down.
- 4. The system must contain functional interlocking controls to automatically shut off the pesticide injection pump when the water pump motor stops.
- 5. The irrigation line or water pump must include a functional pressure switch, which will stop the water pump motor when the water pressure decreases to the point where pesticide distribution is adversely affected.
- 6. Systems must use a metering pump, such as a positive displacement injection pump (e.g., diaphragm pump), effectively designed, and constructed of materials that are compatible with pesticides and capable of being fitted with a system interlock.
- 7. Do not apply when wind speed favors drift beyond the area intended for treatment.

Center Pivot Irrigation Equipment

Notes: (1) Use only with drive systems, which provide uniform water distribution. (2) Do not use end guns when chemigating Prozare SC through center pivot systems because of non-uniform application.

Determine the size of the area to be treated. Determine the time required to apply 1/8 - 1/2 inch of water over the area to be treated when the system and injection equipment are operated at normal pressures as recommended by the equipment manufacturer. When applying **Prozare SC** through irrigation equipment use the lowest obtainable water volume while maintaining uniform distribution. Run the system at 80 - 95% of the manufacturer's rated capacity. Using water, determine the injection pump output when operated at normal line pressure. Determine the amount of **Prozare SC** required to treat the area covered by the irrigation system. Add the required amount of **Prozare SC** and sufficient water to meet the injection time requirements to the solution tank. Make sure the system is fully charged with water before starting injection of the **Prozare SC** solution. Time the injection to last at least as long as it takes to bring the system to full pressure. Maintain constant solution tank agitation during the injection period. Continue to operate the system until the **Prozare SC** solution has cleared the sprinkler head.

Solid Set, Hand Move, and Moving Wheel Irrigation Equipment

When applying **Prozare SC** through irrigation equipment use the lowest obtainable water volume while maintaining uniform distribution. Determine the amount of **Prozare SC** required to treat the area covered by the irrigation system. Add the required amount of **Prozare SC** into the same quantity of water used to calibrate the injection period. Operate the system at the same pressure and time interval established during the calibration. Stop injection equipment after treatment is completed. Continue to operate the system until the **Prozare SC** solution has cleared the last sprinkler head.

Adjuvants: Prozare SC is recommended to be used with a registered non-ionic surfactant at the lowest specified labeled rate for most uses. Refer to USE DIRECTIONS FOR SPECIFIC CROPS for adjuvant recommendations on corn.

MANDATORY SPRAY DRIFT MANAGEMENT

Aerial Applications:

- Do not release spray at a height greater than 10 ft above the ground or vegetative canopy unless a greater application height is necessary for pilot safety.
- Applicators must select nozzle and pressure that deliver medium or courser droplets in accordance with American Society of Agricultural & Biological Engineers Standard 641 (ASABE S641). If the windspeed is 10 miles per hour or less, applicators must use ½ swath displacement upwind at the downwind edge of the field. When the windspeed is between 11-15 miles per hour, applicators must use ¾ swath displacement upwind at the downwind edge of the field.
- Do not apply when wind speeds exceed 15 mph at the application site. If the windspeed is greater than 10 mph, the boom length must be 65% or less of the wingspan for fixed wing aircraft and 75% or less of the rotor diameter for helicopters. Otherwise, the boom length must be 75% or less of the wingspan for fixed-wing aircraft and 90% or less of the rotor diameter for helicopters.
- Do not apply during temperature inversions.

Boomless Ground Applications:

- Applicators must select nozzle and pressure that deliver medium or courser droplets in accordance with American Society of Agricultural & Biological Engineers Standard 572 (ASABE S572).
- Do not apply when wind speeds exceed 15 miles per hour at the application site.
- · Do not apply during temperature inversions.



SPRAY DRIFT ADVISORIES

THE APPLICATOR IS RESPONSIBLE FOR AVOIDING OFF-SITE SPRAY DRIFT. BE AWARE OF NEARBY NON-TARGET SITES AND ENVIRONMENTAL CONDITIONS.

IMPORTANCE OF DROPLET SIZE

An effective way to reduce spray drift is to apply large droplets. Use the largest droplets that provide target pest control. While applying larger droplets will reduce spray drift, the potential for drift will be greater if applications are made improperly or under unfavorable environmental conditions.

Controlling Droplet Size - Aircraft

Adjust Nozzles - Follow nozzle manufacturers' recommendations for setting up nozzles. Generally, to reduce fine droplets, nozzles should be oriented parallel with the airflow in flight.

RELEASE HEIGHT - Aircraft

Higher release heights increase the potential for spray drift.

SHIELDED SPRAYERS

Shielding the boom or individual nozzles can reduce spray drift. Consider using shielded sprayers. Verify that the shields are not interfering with the uniform deposition of the spray on the target area.

TEMPERATURE AND HUMIDITY

When making applications in hot and dry conditions, use larger droplets to reduce effects of evaporation.

TEMPERATURE INVERSIONS

Drift potential is high during a temperature inversion. Temperature inversions are characterized by increasing temperature with altitude and are common on nights with limited cloud cover and light to no wind. The presence of an inversion can be indicated by ground fog or by the movement of smoke from a ground source or an aircraft smoke generator. Smoke that layers and moves laterally in a concentrated cloud (under low wind conditions) indicates an inversion, while smoke that moves upward and rapidly dissipates indicates good vertical air mixing. Avoid applications during temperature inversions.

WIND

Drift potential generally increases with wind speed. AVOID APPLICATIONS DURING GUSTY WIND CONDITIONS. Applicators need to be familiar with local wind patterns and terrain that could affect spray drift.

Boomless Ground Applications:

• Setting nozzles at the lowest effective height will help to reduce the potential for spray drift.

Handheld Technology Applications:

• Take precautions to minimize spray drift.

ROTATIONAL RESTRICTIONS

Treated areas may be replanted with dry beans, peanuts and soybeans as well as any crop specified on this label as soon as practical after last application. For additional crops, do not plant back within 120 days of last application.

USE DIRECTIONS FOR SPECIFIC CROPS

Prozare SC provides control or suppression of many important diseases of barley, corn (field corn, field corn grown for seed, popcorn, and sweet corn), peanut, and wheat. When reference is made to disease suppression, suppression can mean either erratic control from good to fair or consistent control at a level below that obtained with the best commercial disease control products.

Use in conjunction with cultural practices that are known to reduce the severity of soil-borne diseases, such as proper crop rotation practices.
