Evacuate non-essential personnel. Ventilate closed spaces before entering. Consider initial evacuation for 300 meters in all directions. If tank/rail car is involved in the fire, ISOLATE for 800 meters in all directions. Fight fire from a maximum distance. Move containers from fire area if you can do it without risk. Use water spray/fog for cooling fire exposed containers. Withdraw immediately in case of rising sound from venting safety devices or discoloration of tank. Always stay away from tanks engulfed in fire. For massive fire, use unmanned hose holders or monitor nozzles. If this is impossible, withdraw from area and let fire burn. 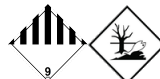

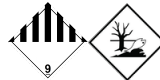
